



- E) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.








- 1.3 The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and financial documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

#### **CLAUSE 2: SCOPE OF THE MOU**



- 2.10 There is no fixed financial commitment on the part of the Shri Gajanan Shikshan Sanstha. If the first Party to take up any program mentioned in the MoU & there is any financial consideration, it will be dealt separately.

#### CLAUSE 3: INTELLECTUAL PROPERTY

Nothing contained in this MOU shall, by express grant, implication, Estoppel 3.1 or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

The knowhow of the joint projects executed under "NDA" (Non-Discloser Agreement) shall be joint IP or whatever decided as per the agreement at the beginning of project.

#### **CLAUSE 4: VALIDITY**

This collaboration is valid for a period of 3 years from the date of this 4.1 agreement and is subject to renewal based on mutual consent. This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period TruScholar - Asset Chain Techlligence Pvt Ltd, the Second Party, as the case may be, will take effective steps for implementation of this MOU.




#### CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES




