1. Background

The Tata Power Skill Development Institute (TPSDI), backed by the legacy of The Tata Power Company, supports Higher Education Institutions (HEIs) by offering vocational courses and industry-ready courses that bridge the gap between academia and industry. These courses, focusing on Green Energy and conventional Power sector skills, equip youth with employable skills.

The Institute's vision is *"To be the Best-in-Class Training Institute for Contemporary and Future Industrial Skills to empower people in a sustainable manner."* The Institute provides application-oriented modular training and certification across a wide range of employable skills.

The Institute has set up six training hubs across four states in India leveraging the facilities of Tata Power and its JV/Subsidiaries:

- Shahad – Mumbai, Maharashtra
- Trombay – Mumbai, Maharashtra
- Vidyavihar – Mumbai, Maharashtra
- Malton – Dhanbad, Jharkhand
- Mundra – Kutch, Gujarat
- Jojobera – Jamshedpur, Jharkhand

The Institute's unique training approach is designed for delivering skills with speed, scale, and standards.

TPSDI collaborates with colleges to offer courses that prepare students for employment and provide them with insights into industry demands.

TPSDI and the College wish to collaborate to bring together the resources and expertise for the benefit of the students.

This Understanding describes the Joint and Individual obligations that TPSDI and College agree to fulfil, to realize the potential of their synergy.

"College" includes the authorities, administrators, teachers, and students enrolled with the College.

2. Understanding

This Understanding outlines the "College's" request for Tata Power Skill Development Institute (TPSDI) to provide training courses and Industry-ready skills trainings at TPSDI centers and/or the college. These courses are designed to enhance students' knowledge and understanding of skills required by the industry. Additionally, the College has expressed interest in jointly designing, developing, delivering, and/or assessing certain courses with TPSDI. Furthermore, the College is open to exploring faculty development programs conducted by TPSDI for its staff.

The courses slated for the academic year **2024-25** are detailed in Annexure A, including the associated fees, subject to revision by mutual agreement. These fees shall be remitted via online bank transfer from the College to The Tata Power Company Limited, prior to the commencement of the course. Any other courses and their fee structures shall be mutually agreed upon between TPSDI and the College.



The College anticipates training approximately 70 students through TPSDI in the academic year **2024-25**.

3. Obligations of Students and College

- The "College" authorities are expected to prioritize and highlight the vocational courses introduced by TPSDI.
- The "College" authorities will ensure adequate communication about the course is shared with students and their parents.
- The "College" will conduct awareness sessions for students regarding vocational courses and make efforts to enroll them.
- The "College" hereby agrees to train **70** number of students at TPSDI within a one-year period. In the event of failure mobilize any students' batches within six months from the date of signing this Understanding, the association shall be considered lapsed. TPSDI reserves the right to issue a formal communication to the Institute, indicating the termination of association with immediate effect.
- All students enrolled in TPSDI courses will adhere to the TPSDI Code of Conduct and Safety Norms for Students. Students are solely responsible for their safety during TPSDI's training sessions, on TPSDI premises, and while staying at accommodation arranged by TPSDI.
- The "College" authorities will attend periodic performance reviews with the TPSDI team to assess progress and take corrective action if needed.

4. Obligations of TPSDI

- TPSDI will provide a "Certificate of Association" to the College after the College trains at least 50 students at TPSDI in a maximum of 3 batches.
- TPSDI will conduct the course and any assessments with all classroom and practical components as per the course curriculum laid down by TPSDI.
- TPSDI will ensure that the curriculum and instructions maintain high quality and meet industrial standards.
- TPSDI will support the "College" in conducting awareness sessions.
- Students will be awarded a joint certificate by TPSDI and the college upon successful completion of the course, assignments, and assessments.

5. Intellectual Property and Copyrights

Both parties acknowledge that any concepts, designs, plans, content, assessments, and processes developed by either party will remain the Intellectual Property and Copyright of that respective party. Neither party will infringe upon the Copyright of the other party. Any use or re-use of the materials of the other party shall only be permitted with prior written consent.

6. The use of Logos

Both parties may utilize the logo of the other party to illustrate the mutual understanding and partnership outlined in this agreement, subject to obtaining written approval for the specific context of use in each instance.

7. Effective Date, Term and Termination

- a. This Understanding shall be effective from the date of the last signature appended hereto.
- b. This Understanding shall remain in force for a period of One (01) Year, unless terminated earlier. The progress and achievements pursuant to this Understanding shall be subject to periodic review by both parties.

- c. This Understanding may be terminated by either party at any time, without cause, upon written notice to the designated Contact person of the other party. Any ongoing transactions or training courses at the time of termination shall be concluded as mutually agreed upon. Any outstanding commercial transactions shall be settled and closed within 30 days of termination. Additionally, this Understanding may be terminated in accordance with the terms and conditions herein if either party fails to fulfill its obligations within the specified timelines.
 - d. The course details and their fee structure shall conform to the description outlined in Annexure I of this document.
 - e. The work plan and tentative batch schedule shall align with the description provided in Annexure II of this document.

No additional rights are conferred upon either party by virtue of this Understanding, except as specifically delineated herein.
