



MEMORANDUM OF UNDERSTANDING

BETWEEN

Shri Sant Gajanan Maharaj College of Engineering - Shegaon

AND

Mew Technology - Bengaluru

This Agreement made and entered into on this 4th day of March 2024 between

Shri Sant Gajanan Maharaj College of Engineering, Khamgaon Road, SHEGAON – 444203 and Mew Technology with its registered office at Bengaluru.

Objective: This MoU aims to foster collaboration between Mew Technology and the Department of Electrical Engineering at Shri Sant Gajanan Maharaj College of Engineering in mutually beneficial areas.

Proposed Modes of Collaboration: Both parties propose to collaborate through supporting R&D projects, which may be conducted entirely at Shri Sant Gajanan Maharaj College of Engineering, and any other appropriate modes of interaction agreed upon between the college and Mew Technology.

Forms of Research and Development Programs: Research programs may take various forms, including individual or concurrent research by each party at their own facilities, joint research in one party's facilities, or in third-party facilities.

Technical Areas of Collaboration: The primary technical areas of collaboration include, Data Acquisition, Internet of Things (IoT), Industrial Internet of Things (IIoT), Machine Learning, Artificial Intelligence, and Embedded System Design.

Agreements for Research Collaboration: Intellectual property and data rights resulting from research conducted by Shri Sant Gajanan Maharaj College of Engineering will remain with the original inventors and the college.

Confidentiality: Both parties agree to treat disclosed information as confidential for one year from the date of disclosure, with exceptions for publicly available information, previously known information, information obtained from third parties, independently developed information, or information required to be disclosed by law.

Non-Exclusivity: The relationship between the parties under this MoU is nonexclusive, allowing both parties to pursue other agreements or collaborations. However, limitations on collaboration may be agreed upon in specific research agreements.

Terms and Termination: The MoU will expire three years after the effective date unless extended by mutual agreement. It may be amended or terminated earlier by mutual agreement.

or unilaterally with 60 days' prior written notice. Termination of the MoU does not affect obligations under any research agreements or confidentiality clauses.

Relationship: This MoU does not create a partnership, agency, or legal representation between the parties for any purpose.

Hands-on-Workshop / SDP: Mew Technology will organize at least one hands-on-workshop on the latest technologies like the Industrial Internet of Things – IIoT, Machine Learning, Artificial Intelligence, Embedded System Design etc., for students as agreed terms and conditions every year. The College will provide the infrastructure facility for conducting such workshops in the campus. Mew Technology will provide certificates for the participants for workshops.

Workshops/Events: If the College wishes to organize a national event in the area of IoT, Machine Learning, Artificial Intelligence, Signal processing & Image Processing, Mew Technology will provide speakers.

Assignment: Both parties acknowledge that this MoU is founded on the professional competence and expertise of each party. Therefore, neither party shall transfer or assign this Agreement, or any rights or obligations arising hereunder, either wholly or in part, to any third party without the prior written consent of the other party. This provision ensures that the collaborative efforts and commitments outlined in this MoU remain between the original parties involved.
