## MEMORANDUM OF UNDERSTANDING

### INTRODUCTION

#### SHRI SANT GAJANAN MAHARAJ COLLEGE OF ENGINEERING, SHEGAON

Shri Sant Gajanan Maharaj College of Engineering, Shegaon (SSGMCE), one of the premier institute in the field of engineering, was established in 1983 by Shri Gajanan Shikshan Sanstha, Shegaon. It is affiliated to Sant Gadge Baba Amravati University, Amravati, recognized by AICTE, New Delhi and approved by DTE, Maharashtra State, Mumbai. SSGMCE offers five Undergraduate engineering courses and five Postgraduate (four Engineering and one Management) courses. All the laboratories have been recognized as research centers for Ph.D programme.

SSGMCE has many experienced, dedicated and talented faculties whom a conducive environment is provided in acquiring higher qualification to enhance their values and career prospects, and in the process raise the quality of its human resource.

### PROPOSAL

Considering the similarity of the Objectives and mutual benefits, the PDKV and SSGMCE mutually agree to enter into a MOU to foster Collaborative Research and Patent Filing, Faculty Exchange Program, Consultancy, project funding, resource mobilization, generation and funding from government, AICTE, semi government organizations etc, conducting workshops, seminars, conferences in collaboration and interdisciplinary interaction.

The terms and conditions of MOU are as follows:

#### **ARTICLE-1**

PDKV will provide subject to personnel and budgetary limitations and as may be mutually agreed upon:

- a) Sponsorship for postgraduate students for carrying out their thesis, research work at SSGMCE on topics of mutual interest.
- b) Laboratory, field, library including online access and other facilities for cooperative research in the area of mutual interest.
- c) Exchange of relevant scientific publications, literature, information, etc.
- d) To allow working space to Scientists and Engineers for demonstration work in PDKV.
- e) To allow collaborative research work and patent filing.
- f) Submission of collaborative Funding proposals to various funding agencies for generating research grants / funds for allied purposes.

#### **ARTICLE-2**

The SSGMCE will provide subject to personnel and budgetary limitations and as may be mutually agreed upon:

- a) Laboratories, equipment, chemicals, glassware, other experimental inputs, supporting manpower, communication facilities, including internet, library facilities and other such requirements which may be necessary for deputed / sponsored students/ staff members only to carry out their assigned work.

#### **ARTICLE-3**

The details of PG studies and related research work are as follows:

- a) SSGMCE will indicate in the beginning of each academic year [June/July] the area of research and the number of students required at Master's and Doctoral level to be sponsored by PDKV to SSGMCE for conducting their thesis research work.
- b) PDKV would identify the suitable and willing students and sponsor them to conduct the research work.
- c) PDKV will constitute the Advisory Committee for such students with a Chairman nominated by PDKV and member nominated by SSGMCE who should have been recognized as a PG teacher by PDKV.

#### ARTICLE-4

The article deals with details of PG students to be selected/ nominated by SSGMCE to work with them for their Master's and Doctoral degrees on the topic identified by them for whom they will bear the entire cost of study at PDKV and at SSGMCE. The details are as follows:

- a) The SSGMCE will select/ nominate students / staff as per requirement in each / any academic year depending upon the need to work for the Masters' / Doctoral degree programmes on the specific problems identified by them and approved by PDKV and SSGMCE.
- b) The entire cost of study of such students will be fully borne by the candidate himself/SSGMCE during the course of their stay by covering boarding lodging, travel and contingencies etc.

#### ARTICLE-5

SSGMCE and PDKV will work together in scientific study.

#### ARTICLE-6

- a) This MOU may be supplemented by work plans to be developed jointly, which describe more specifically the activities to be carried out under this collaborative programme and which set forth the envisaged contributions of each party.
- b) PDKV and SSGMCE may name members of their respective staff to work out further details for proper and effective implementation of this MOU.
- c) Such details as agreed upon, including any other amendments will be confirmed by exchange of letters between PDKV and SSGMCE and such letters will form part of the MOU.
- d) These work plans will require the approval of both parties for implementations.

#### ARTICLE-7

- a) PDKV and SSGMCE recognize the importance of Intellectual Property as a component part of the education and research agenda. The PDKV and the SSGMCE reserve any and all Intellectual Property Rights, without limitation discovered or produced as a result of this cooperation related to this MOU.

- b) During the course of research assignment with SSGMCE and after its completion, all students and staff assigned by PDKV will be required to abide by the PDKV, policy on intellectual property rights.

## ARTICLE-8

This agreement will be in effect for a period of 5 [five] years from the date of signing of this MOU by both parties after which it may be reviewed for possible extension. Either Party may terminate the agreement by written notification signed by the appropriate official of the installation initiating the notice. Such notice must be reviewed by the other party six months prior to the effective termination date. However, obligations and commitments already contracted for and involving third parties shall be honored by both parties until such commitments are completed.

This MOU overrides any prior discussion, correspondence, understanding that may and may not have taken place by and between the parties.

Signed and executed this day of 25 July 2018 by the Dr. Panjabrao Deshmukh Krishi Vidyapeeth Akola and SSGMCE for a period of five years with the seals of both parties affixed herewith.
