MEMORANDUM OF UNDERSTANDING BETWEEN

DEPARTMENT OF ELECTRONICS & TELECOMMUNICATION ENGINEERING, SHRI SANT GAJANAN MAHRAJ COLLEGE OF ENGINEERING AND UNIVERSITY OF ROME TOR VERGATA

The Head Department of Electronics & Telecommunication Engineering (EXTC), Shri Sant Gajanan Maharaj College of Engineering, Shegaon, (SGB Amravati University), MS, India and University of Rome Tor Vergata for the purpose of furthering cooperation of both education and academic research, hereby affirm their intent into promoting such an academic exchange as will be of mutual benefit for their respective universities.

Academic exchange is considered here to include but not limited to:

- · Cooperation research activities;
- Exchange of faculty members;
- Exchange of students;
- · Exchange of scientific materials ,publications and information;
- Other activities as agreed upon by both parties.

Details of the implementation of any particular exchange resulting from this agreement shall be negotiated between the two universities as such specific case may arise.

No financial obligation is presupposed on either party.

This agreement shall be in effect for three /five years, at which time it will be reviewed for possible extension. This agreement may be subject to revision from time to time by mutual agreement. Either party may terminate the agreement by written notification signed by the appropriate official of the institution initiating the notice. Notification of termination should be received by the other party at least six months prior to the effective date of termination, although it is assumed that such action would only be taken after mutual consultation in order to avoid any possible inconvenience to the other university. This agreement shall become effective upon completion of signatures on this day / / 2020.
