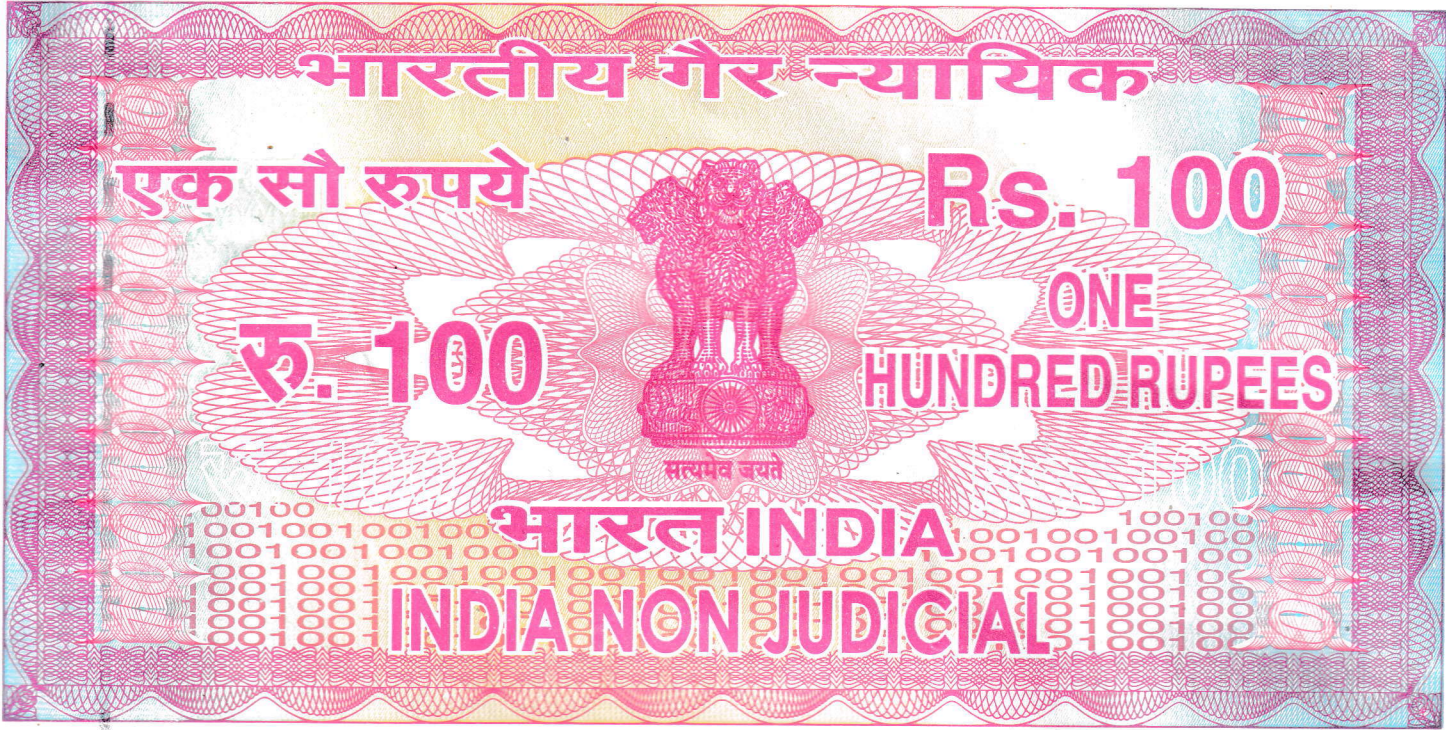

MEMORANDUM OF UNDERSTANDING

Buldhana, State Maharashtra, India, to with respect to the subject matter described in the attached Summary of Terms attached here. BridgeLabz solutions private ltd and Shri Sant Gajanan Maharaj Engineering College Shegaon are referred to here in as the “Parties” or individually as a “Party.”

1. This MOU including the Summary and any attachments hereto, sets forth the current understanding of the Parties. It is expressly agreed that this MOU, including the Summary, is not legally binding upon and does not impose any obligation of any nature on the Parties. Any binding obligations of the Parties, if any, shall be set forth in a separate written agreement by the Parties.
2. Except: (a) to the extent required by applicable law or the rules or regulations or (b) with the prior, written consent of the other Party both as to content and timing; or (c) to the extent known by the general public, the news media or other third parties other than as a result of a violation of the terms of this Section, during the pendency of discussions between the Parties relating to the subject matter of this MOU, no Party will issue any statement or confirm or otherwise disclose to the general public, the news media or to any third party (other than its employees, consultants, advisors and potential investors who have agreed to maintain the confidentiality the information obtained in connection with the contemplated Transaction): (i) that any discussions or negotiations are taking or have taken place between BridgeLabz and Shri Sant Gajanan Maharaj College of Engineering Shegaon relating to the subject of this MOU; or (ii) the existence or contents of this MOU; provided that, in the event of disclosure on account of exceptions described above, the disclosing Party will use reasonable efforts to apprise the other Party in advance of, and afford the other Party a reasonable opportunity to obtain a protective order or confidential treatment before the disclosure. BridgeLabz will be conducting the workshops with latest technology for our Student and assure that no finance appended below.





IN WITNESS WHEREOF, authorized representatives of the Parties have executed this Memorandum of Understanding as of the date first above written.

Summary

1. Roles & Responsibilities of University

- To appoint the SPOC to engage with BridgeLabz on a need basis for smooth conduct of the programs
- Mobilize 1000 candidates for the CodingClub workshops (CIC) to make it viable for BridgeLabz to conduct the overall program. Engage campus ambassadors who would be able to help in the mobilization
- Provide adequate space and infrastructure to conduct the CIC workshop and the Custom Fellowship Program (CFP) in the university premises
- Provide space and infrastructure for BridgeLabz Hiring Partners to conduct the hiring drives for the final year candidates

2. Roles & Responsibilities of BridgeLabz

- To appoint the SPOC to engage with Shri Sant Gajanan Maharaj College of Engineering Shegaon for smooth conduct of the programs
- Conduct the CIC workshop to groom candidates as per industry needs
- To bring BridgeLabz Hiring partners for conducting campus drives for Shri Sant Gajanan Maharaj College of Engineering Shegaon Conduct CFP program for the candidate shortlisted by the BridgeLabz Hiring Partner
- To appoint tech mentors to conduct the CIC workshop and CFP program for the Shri Sant Gajanan Maharaj College of Engineering Shegaon
- Both parties are aware that they would endeavour to achieve the objective of the association to the best of their abilities and work together to mitigate challenges, if any.

3. Indemnification

Both Parties agree to indemnify and keep indemnified other and hold harmless other Party against any costs, losses, damages or liability of any nature incurred by the other Party as a result of any failure on part of either Party (“defaulting party”) to fulfill its respective duties and obligations in terms of this MoU or breach of applicable laws on part of defaulting Party or breach of third party rights on part of defaulting Party.

Renewal of the MOU should not be automatic. A separate renewal/new MOU should be signed after expiry of the present term.
